## ORGANIZATIONAL and MANAGEMENT PROFILE

Under the Diversification plans of PTL, it has established in Year 2007, a state of art tertiary care hospital within a record time of 18 months, in the name of Artemis Health Institute (AHI) in Gurgaon. The 260 bedded hospital is a state of the art institution, built on 8.5 acres of land. The lease agreement is valid for a period up to 2014.
